MAKE YOUR **IMPACT**

You can make an impact now and into the future by donating to WCPP. Gifts to WCPP may include cash, real estate, farmland and outright gifts of retirement assets. All gifts enter an endowment for which a percentage is used toward grantmaking each year. Gifts may qualify for the Endow Iowa Tax Credits, a tax credit of 25 percent of the gifted amount.

WCCP can help citizens achieve their charitable giving goals by setting up a fund which lets a donor direct their assets to the causes they're passionate about. WCPP also assists nonprofit organizations in establishing their own endowment.

- Donor Advised Funds flexible, allowing donors to support multiple causes anytime they choose.
- Designated Funds benefits a single nonprofit organization of the donor's choice, ensuring a steady stream of annual support.
- Legacy Funds Allows donors to establish a plan after their lifetime, knowing the causes they care about are supported for generations.
- Agency Funds Established by a local nonprofit organization to serve as the endowment fund that supports their future operations.
- Committee Advised Funds Group identifies the charitable causes it wishes to support.

Warren County Philanthropic Partnership is a charitable foundation established to help nonprofit organizations, cities and schools in Warren County, lowa, accomplish their vision. Each year WCPP awards grants

to organizations so they may complete projects which benefit the county and improve the quality of life for those who call Warren County home.

Since its inception, it has awarded more than \$1 million to hundreds of projects, making a significant impact in Warren County!

WCPP is an affiliate of the Community Foundation of Greater Des Moines, and this partnership allows WCPP to help people leave a legacy by assisting them in navigating their own charitable giving plans, so they too can give to organizations within their home county.

Grants are awarded to enhance our communities in the following areas:

- Arts, Culture and Humanities
- Education
- Environment and Animals
- Health
- Human Services
- Community and Economic Development

WCPP has supported capital projects, such as replacing valuable equipment for local police and fire departments, improvements to parks and other facilities, and support of local tourism and economic development.

Grants have also been given for program support of schools, libraries, service groups and other organizations, including historic document preservations and educational materials.

Supported projects have grown to have a national impact. WCPP has helped provide equipment for brain injury research, which began as a local effort and now has a more far-reaching affect.

Warren County Philanthropic Partnership provides two types of grants:

- **Community Grant** for projects within the communities of Warren County benefitting a single community, smaller percentage of the citizenship or the entire county.
- **High Impact Grant**, awarded for larger investment projects which make a big impact on multiple communities in the county and a larger percent of the citizenship.
